- Provided victim support to families who have been injured or killed in a drunk or drugged driving crash
- Made other contributions to MADD’s mission or the Campaign to Eliminate Drunk Driving®

**Forms must be filled out and submitted by Friday June 3rd, 2022.** Winners will be notified with a formal invitation to the banquet. A committee of highway safety professionals use a standardized criterion to evaluate the nominations.
